- ☐ **Individual Members** - For individual applicants that are either an American or a Montenegrin citizen and are not affiliated with a company that qualify as a corporate or business member. Annual fee is 420€ + one-time initiation fee is 250€.
- ☐ **Non-Resident Members** - For any legal entity without local registration and that does not have debt or equity investments in Montenegro. Non-resident members shall have no voting privileges. Annual fee is 600€ + one-time initiation fee is 250€.
